- Members of the public attending had previously attended with regard to traffic on the B3079.
- The PC has in the past worked to reduce the speed limit to 30 mph and to have 'pinch points' installed on the road for the purpose of traffic calming.
- Cllr. Thomas explained that the police have repeatedly stated that they will not use data collected by speeding detection devices operated by members of the public. He also explained that the stretch of road in question doesn't fit published criteria for further traffic calming measures.
